- Ask for what you want and take a seat at the table.
- Be self-aware and play to your strengths. It's hard, but have your peers evaluate you in order to better evaluate your strengths.
- Believe in yourself on your own terms.

These were all key take aways, but I believe one panelist may have summed it up best – the best way to "invest and advocate" for another woman is to give her the business. I truly hope each of you will think about this and consider recommending and utilizing another CREW member in your next business transaction.

Columnist and Pulitzer Prize winner. Tom spoke of the future of business in his talk titled the "The World is Flat". With the merger of globalization and IT, Tom reminded us that only in the last 10 years did we have Facebook, LinkedIn, 4G, the Cloud, Skype, Apps, Twitter, and Big Data. Here are her 10 lessons:

- 9. Live your life to leave a legacy. You must be the gift that keeps on giving beyond yourself.
- 10. You have one life to live. Every day is a gift. You must have fun along the way. You have the opportunity to do something amazing every day.

Susan suggested that we create a joy list. She has one. She sets time to work on her list and she is unapologetic about it. As her Mother said, "You can't be good to anybody if you aren't good to yourself."


