MARCH LUNCHEON SUMMARY

Who we saw:

Daniel Levine of Levine Properties spoke to us about 10 square blocks in First Ward and his dream for developing it. Daniel and his father, Mr. Levine, formed Levine Properties in 1984, just after Daniel graduated from UNC Chapel Hill. Levine Properties describes itself as being passionate about creating places to live, work and play. The firm has



seen many successes in the area, such as the Galleria Shopping Center on Monroe Road, McAlpine Park, Greylynn Business Park, and many single use industrial buildings throughout the southeast. But it is First Ward that captured our imaginations at the luncheon.

What he had to say:

The First Ward Project is a patchwork of 60 properties that Levine Properties has assembled over the past 25 yearsâ€yes, it took a quarter century for the First Ward Development and they are just now pulling permits to construct. The Levines are patient. The final property closed on December 28, 2004, and so the planning began. Daniel and his Dad knew what components they needed for their development: a park, residential space, office space, retail, and a significant public

building to anchor the development. Their friend Hugh McColl suggested the park location. UNC Charlotte chose to locate their uptown campus in the Center City Building, a space that borders the planned park. Street closures and construction will start in May 2013 and are expected to last through 2014. Daniel envisions "Market Street" as a tree-lined avenue of granite sidewalks and high-end amenities, designed for pedestrians, street fairs, and outdoor dining. The park offers an open space that can accommodate 4,000 people. Two hotels are planned adjacent to the park with a full block of subterranean parking. Daniel was visibly excited about his First Ward Development as were many others in the room.

One quick mention was made of another Levine Properties project. Publix Stores are moving to Charlotte. Two stores are planned, one urban on South Boulevard and the other suburban located in Ballantyne. Levine Properties, in conjunction with Fort Lauderdale based Stiles, is working to help bring Publix to the Charlotte region.
