

Steve Gassaway and Louis Stephens discussed Charlotte's ability to attract more industries to create headquarters in the area. Unbeatable transportation options, pro-business environment, available work force, and quality of life continue to make Charlotte a top choice for corporate relocations. Gassaway and Stephens had different viewpoints, however, regarding what institutional investors are doing: Gassaway stressed that multi-housing would be the focus with office space lagging behind, while Stephens emphasized that investors are still chasing core properties without seeing much in the secondary markets.

• Charlotte is in the top 5 US cities considered for relocation by corporate headquarters
