- 1. Individuals eligible for nomination for Committee Co-Chair include active 2017 CREW members with completed CREWBiz profiles on the CREW Network web site.
- 2. Individuals eligible for nomination for Director and 2019 President-Elect include active 2017 CREW members with completed CREWBiz profiles on the CREW Network web site who have served as a Committee Co-Chair for at least one year.
- 3. Retiring Members of the 2017 Board of Directors are not eligible to be nominated as Directors, but may be nominated for 2019 President-Elect or Committee Co-Chair. Continuing Members of the 2017 Board of Directors are not eligible to be nominated as Directors or Committee Co-Chairs, but may be nominated for 2019 President-Elect.
- 4. Current Committee Co-Chairs serving a one-year term must be nominated (including self-nomination) to continue leadership service in 2018.
- 5. An individual may be nominated for more than one position. Members making nominations do not have to verify the willingness of an individual to serve; the Executive Committee will confirm candidate interest.
- 6. Self-nominations are encouraged!
- 7. The Executive Committee will determine the willingness of each nominated individual to serve and will request information about the nominees' qualifications and experience in July 2017. They will furnish a list of all accepted nominations to the Strategic Planning Committee and may request comments from the Board of Directors.
- 8. Candidates for 2019 President-Elect will be interviewed by the Strategic Planning Committee in July/August 2017.
- 9. The Board of Directors will approve the slate in September/October 2017 prior to presentation to the membership for a vote, which will take place in October/November 2017.

Our selection process is very transparent and we invite your questions, suggestions, and self-nominations. Please reach out to any member of the Strategic Planning Committee, Committee Leadership or the Board of Directors to ask questions regarding the expectations, time commitment, and benefits of leadership service.

We encourage you to submit nominations, particularly your self-nomination if you are interested in running. The final deadline for all nominations is June 23, 2017. You are very important to the future of this exceptional organization so please be a part of our future success. Thank you.
